MEMORANDUM ON CROSS-EXAMINATION STATEMENTS, AND HEARING EXHIBITS This memorandum is intended to provide additional guidance regarding information to be provided to the Commission in advance of the November 18, 2022 evidentiary hearing.

Cross examination statements and cross examination exhibits are due by 3:00 p.m. on Monday, November 14, 2022.

Cross-examination statements should include:

- (a) The name and email address for each active participant in the hearing, including witnesses and presenting and crossing counsel.
- (b) The estimated time for each witness a party intends to question; ¹ and
- (c) Whether there will be cross-examination regarding confidential materials and, if so, the estimated time and subject matter for each.

Any cross-examination exhibits are also due by 3:00 p.m. on Monday, November 14, 2022. Exhibits must be pre-marked as indicated in OAR 860-001-0480. If you have voluminous exhibits, make arrangements with Ellie Knoll to submit them.

Because this hearing will be conducted electronically, counsel should be prepared to ensure that any documents referenced at hearing are easily accessible to hearings participants, either through relying on submitted exhibits identified by page number, by screen sharing, or by email. In particular, to the extent you intend to rely on spreadsheets or workpapers, counsel are encouraged to provide those to participants in advance for ease of reference.

For witnesses appearing at hearing, parties are encouraged to submit written declarations in support of testimony and exhibits they seek to offer into evidence as well as accompanying motions to admit in lieu of having witnesses adopt their testimony at hearing. For witnesses not appearing at hearing, parties are required to submit declarations and accompanying motions to admit no later than November 26, 2022.
