This memorandum is being issued to (a) discuss the initiation of new docket UM 2253; (b) discuss the continuation of docket AR 638; and (c) set a schedule for both.

First, docket UM 2253 has been initiated in order to establish simplified complaint forms that will aid in ensuring that electric utilities and others can use the new complaint rule developed during the main phase of the AR 638 rulemaking efficiently and expeditiously. AHD informed the Commission of its intention to open this docket at the conclusion of AR 638. A schedule is set out in this proceeding below; in order to help facilitate a productive discussion, AHD will circulate a straw proposal prior to the first written comment dates to which participants may react.

Second, the new complaint process rule, OAR 860-024-0061, was discussed and adopted by the Commission at its Special Public Meeting on August 4, 2022 and is further discussed in the accompanying order issued on September 8, 2022. However, because OAR 860-024-0061 was developed in drafts and workshops throughout the formal rulemaking process, it was not explicitly included in the public rulemaking notice issued by the Commission shortly after the Commission voted to open a formal phase of the rulemaking.

Accordingly, out of an abundance of caution, the Commission will now continue AR 638 in order to issue a new rulemaking notice that explicitly names OAR 860-024-0061 as a potential rule to be adopted. Due to the overlapping nature of these two dockets, we are setting the schedules in both proceedings as laid out below.

Finally, as the Sept. 4 order noted, the Commission also reserved the question of whether and how local ordinances might need to be preempted to allow for tree trimming in emergency situations for a future proceeding. Commission Staff is currently considering that issue and the question of what further proceedings would be beneficial.
