PREHEARING CONFERENCE MEMORANDUM

On October 11, 2022, the Public Utility Commission of Oregon held a prehearing conference in this docket. Idaho Power Company (Idaho Power), Commission Staff, and Stop B2H Coalition (Stop B2H) appeared through their representatives, proposed-intervenor Margie Marie Lyon appeared personally, and interested members of the public also appeared at the prehearing conference.

At the prehearing conference, no party indicated an intent to object to Margie Marie Lyon's petition to intervene in this matter. I found Ms. Lyon had sufficient interest in the proceedings, and that her appearance and participation will not unreasonably broaden the issues, burden the record, or delay the proceedings.¹ I then granted Ms. Lyon's petition to intervene.

During the prehearing conference, I explained the difference between intervenors and interested persons, and explained how one could seek interested person status in this docket.² To clarify, an interested person receives notifications of filings made and documents issued by the Commission or ALJ in this proceeding. An interested person is not a party to the proceeding, and is not entitled to file pleadings, present evidence for the record, conduct cross-examination of witnesses, become a signatory to a protective order, or file briefs. To become an interested person, one should contact the filing center at puc.filingcenter@puc.oregon.gov, request to be listed as an interested person in the PCN 5 docket, and provide their name and contact information.

In advance of the prehearing conference, Idaho Power and Staff submitted a proposed procedural schedule. The Parties had an opportunity to engage in an off-the-record conversation on the proposed schedule in my absence. Subsequently, the Parties were given the opportunity to explain their positions on the record regarding the proposed schedule and answer my questions regarding it. Non-party individuals also provided their perspectives on the proposed schedule. I took all comments, proposals, and requests under advisement.

After considering the proposed schedule from Idaho Power and Staff as well as comments from the Parties and other individuals, I establish and adopt the below procedural schedule. Deadlines related to workshops and data request responses are provided for the parties'

convenience and do not require Commission approval to be rescheduled. Unless other arrangements are made by the Parties, Idaho Power shall be responsible for setting up the appropriate video conference details for any such workshops and distributing them to the parties and any proposed intervenors. Neither the Commissioners nor the Administrative Hearings Division will attend such workshops.
