Petition for Certificate of Public Convenience and Necessity.

On October 17, 2022, I issued a prehearing conference memorandum establishing a schedule in this matter. The prehearing conference memorandum noted the logistical challenges associated with scheduling an evidentiary hearing in April 2023 and asked the Parties to contact the Administrative Hearings Division (AHD) if the scheduled evidentiary hearing dates presented a truly unavoidable conflict. AHD has heard that at least one Party will be observing a religious holiday during the scheduled dates for the evidentiary hearing, and as such, there is a need to find alternate dates for the hearing.

Below are two options reflecting potential schedule changes to coincide with available hearing dates. While these are the only options for an evidentiary hearing, there is flexibility for the testimony and briefing dates with each option.

Note the time between Reply Briefs and Target Date for Commission Decision should not be reduced.

Joint or individual proposed schedules should be emailed to the service list and Filing Center by 9:00 a.m. on Wednesday, October 26, 2022.

On October 18, 2022, Idaho Power Company filed a request for clarification regarding a discovery-related deadline. The schedule will be clarified, in a memorandum establishing a revised schedule.
