Request for a General Rate Revision.

DISPOSITION: MOTIONS TO ADMIT TESTIMONY GRANTED; RECORD CLOSED

On September 8, 2010, the procedural schedule in these proceedings was suspended after Portland General Electric Company (PGE) notified the Public Utility Commission of Oregon (Commission) that the parties had settled all issues in this docket.
