**RULING**

**DISPOSITION:        MOTIONS GRANTED; TESTIMONY AND EXHIBITS  
                         ADMITTED; RECORD CLOSED**

On July 8, 2013, the Citizens' Utility Board of Oregon (CUB) filed a motion to admit its opening testimony and exhibits, CUB/100-103 filed on June 14, 2013. On July 10, 2013, Portland General Electric Company filed a Motion to Admit Partial Stipulation and Joint Testimony in Support of Stipulation (First Partial Stipulation), (Stipulating Parties/100). On July 11, 2013, Wal-Mart Stores, Inc., filed a motion to admit opening testimony and exhibits Wal-Mart/100-101 and Joint Testimony in Support of Stipulation (Stipulating Parties/100). On July 31, 2013, the City of Portland filed a motion to admit opening testimony and exhibits COP/100-107, COP/200-204, and COP/300.

On August 20, 2013, PGE filed a motion to admit the Second Partial Stipulation and Joint Testimony in Support of Stipulation (Stipulating Parties/200-201).

On September 20, 2013, PGE filed a motion to admit pre-filed testimony and exhibits PGE/100, PGE/200-203, PGE/300-311, PGE/400-402C, PGE 500-503C, PGE/600-605, PGE/700-705, PGE/800-801C, PGE/901-905, PGE/1000-1006, PGE/1100-1102, PGE/1200-1216, PGE/1300-1311, PGE/1400-1401, PGE/1500-1507, PGE/1700-1702, PGE/1800, and PGE/2000-2005. On September 23, 2013, the Commission Staff filed a motion to admit testimony, Staff/100-101, Staff/200-201, Staff 300-302, Staff/400-403, and Staff/500-501. On September 23, 2013, PGE filed a motion on behalf of the parties to admit the Third Partial Stipulation and Joint Testimony in Support of the Third Partial Stipulation (Stipulating Parties/300). On September 27, 2013 the Industrial Customers of Northwest Utilities filed a motion to admit its pre-filed testimony (ICNU/100C, 100, 102C, and ICNU/200), and Joint Testimony in Support of Third Partial Stipulation (Stipulating Parties/300). On September 27, 2013 Noble Americas Energy Solutions filed a motion to admit its reply testimony (Noble Solutions/100)<sup>1</sup>. On September 30, 2013, CUB filed a motion to admit pre-filed reply testimony CUB/201-202 as well as its

opening testimony and the joint testimony in support of the three partial stipulations for which it was also a witness.

All motions were supported by witness affidavits and no party objected to the motions of the other parties.

I find that the testimony and exhibits offered by the parties meet the standards for relevance as required by OAR 860-001-0450(1) and satisfy the requirements of OAR 860-001-0480. The testimony and exhibits offered by CUB, ICNU, the City of Portland, Wal-Mart, Staff, Noble Solutions, and PGE, both for itself and on behalf of the stipulating parties, are admitted into the record of this proceeding.

The record is closed.
