DOCKETS CONSOLIDATED; PROCEDURAL SCHEDULES ADOPTED

On November 2, 2016 Idaho Power Company made two filings relating to revised depreciation rates. In the filing docketed as UM 1801, Idaho Power seeks authorization to institute revised depreciation rates and adjust Oregon base rates accordingly. In the filing docketed as UE 316, Idaho Power seeks to increase its rates to recover costs associated with accelerating the depreciation schedule for the North Valmy Power Plant. To date, the parties to these dockets consist of Idaho Power, the Citizens' Utility Board of Oregon (CUB), and the Commission Staff.

On December 21, 2016, Staff's counsel sent an e-mail to the Administrative Law Judges, copying all parties, requesting that the two dockets be consolidated and proposing an agreed-upon procedural schedule. We treat this e-mail correspondence as a joint motion of Idaho Power, CUB, and Staff to consolidate these dockets and adopt the proposed schedules.

The joint motion explains that in both dockets Idaho Power is requesting ratemaking treatment and that arguments about rate-recovery could be the same in both cases. For efficiency purposes, the parties propose consolidating the dockets so that all testimony regarding ratemaking treatment may be filed in docket UE 316.

With respect to procedural schedules for these dockets, the parties propose separate, coordinated procedural schedules. The proposed schedule in docket UM 1801 allows all substantive issues (other than ratemaking treatment) to be resolved by June 1, 2017, thereby ensuring that Idaho Power's change in depreciation rates would be in sync with its pending change before the Idaho Public Utilities Commission. The parties have agreed to a rate effective date for both dockets of no later than November 1, 2017.

RULING

The joint motion to consolidate these two dockets and adopt the proposed schedules is granted. Consolidating these dockets will allow for one set of testimony addressing ratemaking treatment. The following procedural schedules are adopted:
