DISPOSITION: EXPEDITED MOTION TO AMEND PROCEDURAL SCHEDULE GRANTED

On June 29, 2020, Staff of the Public Utility Commission of Oregon filed a motion to amend the procedural schedule in this docket. Staff seeks to move the deadline for Staff and Intervenor Rebuttal and Cross Answering Testimony on Coal Decommissioning Costs and the Independent Evaluator Report from July 24, 2020 to July 17, 2020. Staff indicates that the timing of the Independent Evaluator's report necessitated a separate schedule for coal decommissioning issues, and that accelerating this deadline achieves a balance of the time remaining in the existing schedule between PacifiCorp and the other parties to address these issues. Staff proposes that the procedural schedule will otherwise remain unchanged, with PacifiCorp's response to both the Independent Evaluator's report and Staff and Intervenors' positions to be included in PacifiCorp's surrebuttal testimony. Staff represents that it conferred with all parties to this proceeding, and no party objects.

I find good cause to grant Staff's motion. The remaining procedural schedule for this proceeding as amended by this ruling is set forth below.
