## DISPOSITION: TESTIMONY AND EXHIBITS ADMITTED

Calpine Solutions, the Oregon Citizens' Utility Board (CUB), Klamath Water Users Association (KWUA), PacifiCorp, dba Pacific Power, Commission Staff, Sierra Club, and Vitesse LLC filed motions to admit: prefiled testimony, exhibits, the stipulation and joint testimony along with supporting declarations from the witnesses. The Alliance of Western Energy Consumers (AWEC) filed a motion seeking to admit Mr. Mullins prefiled testimony and exhibits without a declaration because Mr. Mullins has relocated and is unavailable.
