RULING

DISPOSITION: TESTIMONY AND EXHIBITS ADMITTED

Calpine Solutions, the Oregon Citizens' Utility Board (CUB), Klamath Water Users Association (KWUA), PacifiCorp, dba Pacific Power, Commission Staff, Sierra Club, and Vitesse LLC filed motions to admit: prefiled testimony, exhibits, the stipulation and joint testimony along with supporting declarations from the witnesses. The Alliance of Western Energy Consumers (AWEC) filed a motion seeking to admit Mr. Mullins prefiled testimony and exhibits without a declaration because Mr. Mullins has relocated and is unavailable. AWEC states that the stipulating parties do not oppose its motion. For the joint testimony in support of the stipulation, AWEC included a declaration from its sponsoring witness Dr. Lance Kaufman, with Dr. Kaufman's witness qualification statement attached to AWEC's motion.

I find the stipulation, testimony and exhibits offered by the parties meet the standards for relevance as required by OAR 860-001-0450(1), satisfy the general requirements of OAR 860-001-0480, and also meet the requirements for settlements and supporting testimony in OAR 860-001-0350(7). Additionally, I take official notice under OAR 860-001-0460(d) of PacifiCorp's responses to Bench Requests 1 through 3.4.
