## DISPOSITION: MOTION GRANTED; SCHEDULE MODIFIED

On June 25, 2020, Portland General Electric Company (PGE) filed a motion to modify the procedural schedule in this docket. PGE filed Supplemental Testimony regarding a recently executed contract with the Public Utility District No. 1 of Douglas County for surplus capacity and energy (the Douglas Contract) on June 8, 2020. PGE seeks a schedule change to provide parties with a full opportunity to address the Supplemental Testimony on the Douglas Contract. PGE requests that the deadline for submission of Opening Testimony by Staff and Intervenors, including the Alliance of Western Energy Consumers (AWEC) and the Oregon Citizens' Utility Board (CUB), of July 9, 2020, to be added to the procedural schedule. To facilitate testimony regarding the Douglas Contract, PGE offers to use best efforts to respond to discovery requests about the Douglas Contract in seven days. PGE indicates that Staff, AWEC, and CUB support the motion. As Staff and Intervenors' Opening Testimony is currently due on June 26, 2020, PGE requests expedited consideration.

I find good cause to grant PGE's motion. Based on timing issues and support for the motion from Staff and the Intervenors, I grant the motion on an expedited basis. I adopt a modified schedule for the docket, as follows:
