RULING

DISPOSITION: TESTIMONY AND EXHIBITS ADMITTED; RECORD CLOSED

Between February 8 and February 15, 2022, Alliance of Western Energy Consumers (AWEC), Calpine Energy Solutions, LLC, Walmart, Inc., Small Business Utility Advocates (SBUA), Fred Meyer Stores and Quality Food Centers, Division of The Kroger Co. (Kroger), the Oregon Citizens' Utility Board (CUB), Portland General Electric Company, and Staff of the Public Utility Commission of Oregon each moved to admit their respective prefiled testimony and exhibits into the record.<sup>1</sup> Additionally, PGE filed motions to admit the four partial stipulations, prefiled testimony and exhibits on behalf of the stipulating parties to each settlement. I find the testimony and exhibits offered by the parties and adopted by or supported by declarations of the witnesses meet the standards for relevance as required by OAR 860-001-0450(1) and satisfy the requirements of OAR 860-001-0480. No party opposed the admission of any testimony or exhibits. The stipulation, testimony, and other exhibits are admitted into the record as identified in the parties' motions and at the February 10, 2022 evidentiary hearing.<sup>2</sup>

Consistent with the February 17, 2022 ruling issued by Chief Administrative Law Judge Moser in this docket, the letter filed on February 9, 2022 by Natural Resources Defense Council and Northwest Energy Coalition, as well as their reply, filed March 11, 2022, are also admitted into the record.
