MEMORANDUM REGARDING MARCH 4, 2022 ORAL ARGUMENT

Request for a General Rate Revision.

The Commission will conduct an oral argument in this proceeding on March 4, 2022 on the remaining litigated issues, except for wildfire mitigation, vegetation management, and decoupling, to be addressed at the March 17, 2022 oral argument. I requested that the parties confirm no later than February 28, 2022, whether they intend to participate in the March 4, 2022 oral argument, and to identify the topics that they seek to address. After consultation with the Commission, oral argument will be structured with specific portions of the proceeding addressing the topics listed below. The below agenda identifies the parties that will be participating in the order in which they will be presenting. I anticipate taking a 15 minute recess after concluding with the level III outage mechanism, and before starting with the deferrals portion of the agenda.

Please note that the Commissioners will attend the oral argument, and the time allotted includes the time to address any questions from the Commissioners. Parties should be prepared to address questions from the Commissioners and should anticipate questions starting within the first few minutes of their presentations. Additionally, while parties may use screen sharing to the extent necessary to show an exhibit for illustrative purposes, the use of power point presentation is strongly discouraged.
