2023 Transitional Adjustment Mechanism.

DISPOSITION: MOTION TO ADMIT STIPULATION AND JOINT TESTIMONY AND EXHIBITS GRANTED; MOTIONS TO ADMIT PRE-FILED TESTIMONY AND EXHIBITS GRANTED.

On August 11, 2022, a joint stipulation was filed in this docket, along with joint testimony in support of the stipulation.
