DISPOSITION: MOTION GRANTED AND LIVE TESTIMONY ACCEPTED; TESTIMONY AND CROSS-EXAMINATION SCHEDULE ADOPTED

On September 1, 2023, PacifiCorp filed a motion for leave to present live testimony. Also on September 1, Staff for the Oregon Public Utility Commission replied that it did not oppose that motion if it had leave to cross-examine that witness if necessary.
