Request for a General Rate Revision (UE 435),

Advice 20-19, Schedule 198 Renewable Natural Gas Recovery Mechanism (ADV 1215) (UG 411).

DISPOSITION: MOTION TO MODIFY PROCEDURAL SCHEDULE GRANTED

On May 31, 2022, Northwest Natural Gas Company, dba NW Natural, filed a Multi-Party Partial Stipulation (partial stipulation) resolving several issues in these proceedings on behalf of the following parties to the docket: NW Natural; the Staff of the Public Utility Commission of Oregon; the Oregon Citizens' Utility Board; the Alliance of Western Energy Consumers; and the Small Business Utility Advocates (collectively, the Stipulating Parties). As part of its filing, NW Natural indicated that the remaining parties, the Coalition for Communities of Color, Climate Solutions, Verde, Columbia Riverkeeper, Oregon Environmental Council, Community Energy Project, and Sierra Club (Coalition), did not join the partial stipulation and intended to litigate issues addressed in the partial stipulation. On June 8, 2022, the Stipulating Parties filed joint testimony in support of the partial stipulation. As set forth in the ruling issued June 2, 2022, any objections to the partial stipulation would be due on June 23, 2022.

On June 14, 2022, NW Natural filed a motion to modify the procedural schedule to clarify the timing and process for addressing the expected objection to the partial stipulation. NW Natural states that its proposed modifications are intended to align the process for addressing objections to the partial stipulation with the existing schedule. NW Natural states that it has conferred with the parties in these proceedings and represents that the parties support its motion.

I grant NW Natural's motion to modify the procedural schedule. The schedule for the remainder of these proceedings is, as follows:
