Request for a General Rate Revision (UG 435),

Advice 20-19, Schedule 198 Renewable Natural Gas Recovery Mechanism (ADV 1215) (UG 411).

DISPOSITION: TESTIMONY AND EXHIBITS ADMITTED; RECORD CLOSED
