MEMORANDUM ON STAFF'S SCHEDULING MOTION

On February 9, 2024, Staff of the Public Utility Commission of Oregon filed a request for the Commission to hold a Commissioner workshop to discuss issues impacting environmental justice communities. On April 10, 2024, Staff filed a motion to modify the procedural schedule that requested a workshop to be held April 25, 2024, and that would not be attended by the Commissioners. Staff stated that it was requesting this change to the requested workshop after lessons learned from the workshop held in docket UE 426. Staff requested expedited consideration of this motion.

To the extent that this is a workshop to be held without attendance by the Commissioners and is intended to be a workshop for the parties and other invited stakeholders, the parties do not need permission from the Commission to schedule and hold this workshop. No workshop was ever scheduled with the Commissioners in this docket and there is no change to an existing event that must be made. For ease of reference, however, I revise the schedule to include the workshop described by Staff in its motion filed April 10, 2024. To the extent that the parties need or want to alter the date of this workshop, however, the parties are not obligated to notify the Commission or seek a modification of the schedule.
