MEMORANDUM

A hearing in the above-captioned docket was scheduled to be held on August 3, 2006, beginning at 9:30 a.m. The Industrial Customers of Northwest Utilities (ICNU) was scheduled to conduct cross-examination of Portland General Electric Company's (PGE) witness panel, consisting of Pamela Lesh and Jay Tinker. I was informed, on August 2, 2006, however, that ICNU agreed to waive cross-examination, and parties agreed to allow ICNU to move certain documents, identified in Attachment A, into the record.

Due to the timing of notice of ICNU's waiver, the hearing was not cancelled. The following parties made appearances at the hearing, in person or by telephone: Stephanie Andrus, on behalf of Staff of the Public Utility Commission of Oregon (Commission); Doug Tingey, on behalf of PGE; Brad Van Cleve, on behalf of ICNU; and Jason Eisendorfer and Lowrey Brown, on behalf of the Citizens' Utility Board (CUB).

Parties agreed to submit motions to admit testimony and exhibits into the record. As testimony must be sworn to, if a party's testimony was not submitted with an affidavit as to its truth, that party's motion to admit the testimony should be submitted with such an affidavit.

Parties also discussed the schedule for oral argument. After further consultation with parties and the Commissioners, I have determined that oral argument should be scheduled for the morning of October 3, 2006. As this date is nearly one month after the due date for

reply briefs, I will adjust the briefing schedule to allow for one more week for the submission of both rounds of briefing. The post-hearing schedule is as follows:
