DISPOSITION: EVIDENTIARY RECORD REOPENED TO ADMIT TESTIMONY AND EXHIBITS

I. SUMMARY

In this Ruling, the Administrative Law Judge (ALJ) reopens the record for the purpose of admitting the testimony of Michael G. Williams, and for the admission of portions of the record of the Applicants' Application in proceedings before the Utah Public Service Commission.

II. BACKGROUND

The Public Utility Commission of Oregon (Commission) conducted hearings in these proceedings on December 16 and 17, 2010, in Salem, Oregon. At the hearing, the parties agreed to accept the written rebuttal testimony of Michael G. Williams (Williams Rebuttal Testimony) into the record and such other testimony and additional documents as the parties mutually agreed to submit.¹

By Ruling of December 27, 2010, ten days after the close of the hearing, all written testimony and exhibits offered but not previously entered into the record due to the absence of sponsoring witnesses or affidavits, such affidavits having subsequently been filed, were admitted, and the record closed. Neither the Williams Rebuttal Testimony nor the portions of the record in the Applicants' Utah proceedings had been submitted by that date.

The Rebuttal Testimony entitled "Affidavit of Michael G. Williams Regarding Alternate Plan of Regulation" was filed on January 7, 2011, by counsel for Qwest Communications International, Inc. Additional evidentiary materials supported by affidavit were filed by counsel for several intervening parties, previously identified as the Joint CLECs, on January 7, 2011 (portions of the record in the Applicants' Utah proceedings). A list of the documents filed by Joint CLECs is set forth in Attachment A to this Ruling.

III. DISCUSSION

At the hearing, the parties indicated that they did not object to the submission of the Williams Rebuttal Testimony and would reach a mutual agreement on the submission of additional evidentiary materials. Accordingly, the Record should be reopened for the purpose of admitting the testimony and additional evidentiary materials.

IV. RULING

- 1. The Record is reopened.
- 2. The Affidavit of Michael G. Williams Regarding Alternate Plan of Regulation and the additional evidentiary materials identified in Attachment A to this Ruling are admitted into the record; and
- 3. The Record is now closed.
