RULING

DISPOSITION: MOTIONS TO ADMIT TESTIMONY INTO THE RECORD GRANTED

On March 29, 2019, Sunriver Water, LLC (SRW), NW Natural Water of Oregon, LLC (Oregon Water), the Sunriver Owners Association (SROA), Sunriver Resort Limited Partnership (Sunriver Resort), the Oregon Citizens' Utility Board (CUB) and the Staff of the Public Utility Commission of Oregon (Staff) (collectively, the Stipulating Parties) filed a Stipulation and Joint Testimony in Support of the Stipulation.

On March 29, 2019, Staff filed a motion to admit prefiled testimony and exhibits Staff/100-103 into the record supported by the declaration of Stephanie Yamada.

On April 1, 2019, the following motions were filed:

Oregon Water filed a motion on behalf of the Stipulating Parties to admit the Stipulation and Joint Testimony in Support of the Stipulation.

Oregon Water filed a motion to admit the prefiled testimony Oregon Water/100 and Oregon Water-SRW-Staff-CUB-SROA/100, supported by the affidavit of Justin Palfreyan.

SROA filed a motion to admit the prefiled testimony SROA/100 supported by the affidavit of Hugh Palcic.

On April 3, 2019, SRW filed a motion to admit the prefiled testimony Sunriver Water, LLC/Ex. 100, supported by the declaration of Thomas O'Shea.

On April 4, 2019 CUB filed a motion to admit prefiled testimony CUB/100-101, Gehrke and to admit the Stipulating Parties Joint Testimony in support of the Stipulation (Oregon Water-SRW-Staff-CUB & SROA/100, Palfreyman, O'Shea, Yamada, Gehrke, and Palcic) and the supporting declaration of William Gehrke.

RULING

The motions to admit testimony, exhibits and supporting declarations and affidavits are granted and the testimony, exhibits and supporting declarations and affidavits referred to therein are each admitted into the record.
