Request for a General Rate Revision.

DISPOSITION: MOTION TO MODIFY SCHEDULE GRANTED

On May 22, 2018, Government Camp Water Company and the Commission Staff filed a joint motion requesting that the procedural schedule be modified to accommodate a "redirection" of the company's resources while it makes necessary filings seeking Commission approval of several transactions that have implications for the rate case.¹ The company and Staff agree that the company will make these additional filings by June 5, 2018.

The modified schedule is necessary to enable the Commission to consider and make a decision regarding these transactions before making its decision in the rate case. According to the parties, this approach is reasonable because each of the transactions may have a significant effect on the inputs to and outcome of the rate case.

When Government Camp filed its application, the Commission suspended the rate filing for nine months, which expires on October 31, 2018. To accommodate the revised procedural schedule Government Camp requests that we extend the tariff suspension period by five months, to March 31, 2019.² The parties expect that the extension of the suspension period will accrue to the benefit of the customers by delaying the likely rate increase.³

¹ The transactions include (1) the 2014 transfer of the company to a new owner; (2) an affiliated interest lease for office space; (3) an affiliated interest lease for storage space; (and (4) an affiliated interest agreement pertaining to the new owner's salary.

 $^{^{2}}$ Under ORS 757.215(2) the utility and the Commission may enter into a "written stipulation "at any time extending the period of suspension.

³ The original motion was signed only by Staff. Because the statute requires that the utility consent to the extension of the suspension period, Staff is directed the parties to refile its motion with the company's signature included.
