PREHEARING CONFERENCE  
MEMORANDUM

On May 28, 2019, the Public Utility Commission of Oregon held a prehearing conference in this docket. Representatives appeared on behalf of Portland General Electric Company (PGE), Oregon Citizens' Utility Board, Northwest and Intermountain Power Producers Coalition (NIPPC), Renewable Energy Coalition (Coalition), Renewable Northwest, Northwest Energy Coalition (NWECA), National Grid USA (National Grid), and Alliance of Western Energy Consumers (AWEC) and Commission Staff.

**Petitions to Intervene**

Prior to the conference, NWECA, Renewable NW, AWEC, NIPPC, Coalition, and National Grid filed petitions to intervene in this docket. No party attending the conference objected to the petitions. Although a proceeding to review a utility's integrated resource plan (IRP) is not considered a contested case proceeding under ORS 183.310(2), the Commission grants petitions to intervene for the limited purposes of: 1) creating a service list; and 2) establishing eligibility to sign a protective order. The petitions to intervene filed by NWECA, Renewable NW, AWEC, NIPPC, Coalition, National Grid are granted for the limited purpose described above. In addition, Oregon Citizens' Utility Board filed its notice of intervention as allowed under ORS 774.180.

**Procedural Schedule**

The parties jointly presented a procedural schedule. We have made the following changes:

- Changed PGE's July 30 Public Meeting presentation from "Informational Only" to "Public Hearing". The Informational Only designation refers to situations where only the utility and Staff are interacting with the Commission. PGE's July 30 presentation will be a "Public Hearing" item to allow for stakeholders to make brief comments describing their main areas of inquiry in this proceeding. The

purpose of the stakeholders' high level comments are to help the Commissioners understand areas they should focus on. We ask that stakeholders refrain from adversarial comments, as intervenors' positions on issues can be fully explained in the three sets of written comments, during the subsequent Commission workshop, and in the final Public Meeting.

- Added a date for PGE and intervenors to file comments on Staff's Public Meeting memorandum (the Thursday before the Public Meeting).
- We have added the Public Meeting date of January 28, 2020, and marked it as tentative because the Commission has not yet set its 2020 public meeting dates.
- Removed the January 30, 2020 Commission Order date, because the Commission's decision on IRP acknowledgement is effective when it is made at the public meeting.<sup>1</sup>

With those changes, the following procedural schedule is adopted:

Beginning October 14, 2019, the parties agreed to a seven calendar day data response turn-around.
