PREHEARING CONFERENCE  
MEMORANDUM

On October 1, 2021, the Public Utility Commission of Oregon held a prehearing conference in this docket. Representatives appeared on behalf of the Alliance of Western Energy Consumers (AWEC), Commission Staff, NewSun Energy, NW Energy Coalition (NVEC), the Northwest and Intermountain Power Producers Coalition (NIPPC), the Oregon Citizens' Utility Board, PacifiCorp, dba Pacific Power, Renewable Energy Coalition, Renewable Northwest, and Sierra Club.

**Petitions to Intervene**

Prior to the conference, petitions to intervene were filed by AWEC, NIPPC, NewSun, Swan Lake North Hydro and FFP Project 110, Renewable Energy Coalition, and NVEC. No party attending the conference objected to the petition. This proceeding is not a contested case proceeding under ORS 183.310(2). Nonetheless, obtaining party status is necessary for purposes of being on the eDockets "service list" that is used for electronic mail notifications of filings made and documents issued. Party status is also necessary to become a signatory to a protective order. For those reasons, the Commission will grant the petitions to intervene in proceedings using a Public Meeting decision making process.

The petition to intervene filed by AWEC, NIPPC, NewSun, Swan Lake North Hydro, Renewable Energy Coalition, and NVEC are granted for the limited purposes described above.

**Procedural Schedule**
