DISPOSITION: UE 246 HEARING SCHEDULE ADOPTED;
 UE 233 HEARING CANCELED

On October 8, 2012, the Commission held a telephone conference to discuss the hearings scheduled to take place on October 15-16, 2012. Representatives appeared on behalf of Commission Staff; Renewable Northwest Project (RNP); NW Energy Coalition; Industrial Customers of Northwest Utilities (ICNU); Citizens' Utility Board of Oregon (CUB); Sierra Club; PacifiCorp, dba Pacific Power; and Idaho Power Company.

After reviewing the parties' cross-examination requests, I adopt the following schedule for the UE 246 hearing:

On October 10, 2012, I called counsel for PacifiCorp to clarify the subject matter of PacifiCorp's proposed cross-examination of Mr. Deen. Counsel informed me that PacifiCorp intends to cross-examine Mr. Deen and Staff witness Mr. Schue regarding PacifiCorp's PCAM.

To reduce time spent on administrative tasks at the hearing, I intend to admit parties' direct testimony and exhibits into the record by ruling after the hearing.

UE 233: No party requests the opportunity to cross-examine a witness in UE 233. As a result, I am removing UE 233 from the hearing schedule.
