Judge Pines, Following up on your ruling on August 19, the parties have started conferring on a proposed schedule for briefing in this case. Two preliminary questions came up and the parties agreed to ask for your guidance on them.

First, the March 6, 2013 ruling in this case and docket UE 263 directs sequential post-hearing briefs. CUB and ICNU have requested that there only be one simultaneous closing brief. PacifiCorp supports sequential briefing as directed by the order. If the Commission is open instead to a simultaneous schedule, PacifiCorp requests an opportunity to file a reply brief, similar to all prior TAM cases. CUB and ICNU object stating that they do not believe there is need for more than the one simultaneous brief.

Second, the schedule in this case includes a target date for the final order of October 29, 2013. In setting our briefing schedule, when does the case need to be finally submitted to allow the Commission to issue an order by that date? CUB and ICNU have pointed out that one simultaneous brief would help in meeting this schedule. PacifiCorp believes there is sufficient time to accommodate whatever briefing schedule the Commission directs.

Please advise on the Commission's preferences with respect to the sequence for post-hearing briefs in this case. The parties are also available to address these issues through a telephone conference.
