NOTICE OF USE OF GENERAL PROTECTIVE ORDER

PacifiCorp d/b/a Pacific Power (PacifiCorp) hereby provides notice that it anticipates designating information to be produced or used in this docket as protected under the Commission's General Protective Order, No. 23-132 (GPO). The information designated as confidential includes commercially sensitive and confidential business information related to the Company's long-term resource planning that falls within the scope of ORCP 36(C)(l) or the exemptions under Oregon Public Records Law, ORS 192.345 and 192.355 and is not publicly available.
