**NOTICE OF USE OF GENERAL
PROTECTIVE ORDER**

Idaho Power Company (Idaho Power) hereby provides notice that it anticipates designating information to be produced or used in this docket as protected under the Commission's General Protective Order No. 23-132 (GPO). On September 29, 2023, Idaho Power filed its Application and 2023 Integrated Resource Plan. Idaho Power anticipates that Staff will seek to discover confidential business information in the discovery process. The Commission's rules authorize Idaho Power Company to seek reasonable restrictions on discovery of trade secrets and other confidential business information. See OAR 860-001-0080 and ORCP 36(C)(1) (providing protection against unrestricted discovery of "trade secret[s] or other confidential research, development, or commercial information"). Issuance of a protective order will facilitate the production of relevant information and expedite the discovery process. Other parties to the proceeding may seek access to the protected information under the terms of the GPO using the signatory pages in Order No. 23-132.
