## NOTICE OF USE OF GENERAL PROTECTIVE ORDER

Portland General Electric Company (PGE) hereby provides notice that it anticipates designating information to be produced or used in this docket as protected under the Commission's General Protective Order, No. 23-132 (GPO). PGE's forthcoming initial filing for a Petition for Certificate of Public Convenience and Necessity (Petition) will contain commercially sensitive and confidential business information that falls within the scope of ORC 36(C)(1) or the exemptions under ORS 192.345 and 192.355 and is not publicly available. PGE will also be providing Responses to Standard Data Requests, pursuant to OAR 860-025-0030, which will include, among other things, confidential material concerning critical energy infrastructure, transmission planning and studies, transmission capacity, and contracts and contract pricing. Public disclosure of the confidential information would be detrimental to PGE and its customers. In addition to the Standard Data Requests containing confidential information, it is likely that Staff and others in this proceeding will seek to discover additional confidential business information. The GPO can be found on the Commission's Reports and Forms webpage<sup>1</sup>. Other parties to the proceeding may seek access to the protected information under the terms of the GPO using its attached signatory pages.

The individuals listed in the table below are employees of PGE and are identified for purposes of accessing information designed as protected by PGE within the docket. PGE will provide updates to this table during the course of the proceeding to ensure that it accurately identifies the employees who should have access.
