ORS 774.020. CUB's membership averages 4,500 persons per year.
- d. CUB intends to monitor the proceeding and, if necessary, raise issues that are appropriate to the proceeding. No other party could adequately represent the interest of utility consumers.

- e. CUB has participated in Commission proceedings since its inception in 1985.
