**NOTICE OF USE OF GENERAL  
PROTECTIVE ORDER**

Idaho Power Company (Idaho Power) hereby provides notice that it anticipates designating information to be produced or used in this docket as protected under the Commission's General Protective Order No. 23-132 (GPO). On October 31, 2023, Idaho Power plans to file its 2024 Annual Power Cost Update (APCU). The workpapers that will accompany the filing will include confidential business information. In addition, Idaho Power anticipates that Staff and intervenors will seek to discover confidential business information in the discovery process. The Commission's rules authorize Idaho Power Company to seek reasonable restrictions on discovery of trade secrets and other confidential business information. See OAR 860-001-0080 and ORCP 36(C)(1) (providing protection against unrestricted discovery of "trade secret[s] or other confidential research, development, or commercial information"). Issuance of a protective order will facilitate the production of relevant information and expedite the discovery process. The GPO is available at: <https://apps.puc.state.or.us/orders/2023ords/23-132.pdf>. Other parties to the proceeding may seek access to the protected information under the terms of the GPO using the signatory pages in Order No. 23-132.
