

CUB recognizes that intervention in a complaint proceeding may be rather unusual, however, the importance of the issues raised in ACLU's complaint for telephone utility customers, and the implications on the privacy rights for all utility customers are quite significant. CUB also suggests that the Commission consider opening an investigation on the matters raised in ACLU's complaint pursuant to its authority in ORS

756.515. Given the interests involved, a Commission investigation may result in a more inclusive process and a more thorough examination of the issues.


