In NW Natural's 2018 Integrated Resource Plan (IRP) the Company requested approval ("acknowledgement") of its methodology for determining the cost-effectiveness of bringing renewable natural gas (RNG) resources to customers. The methodology is described in Appendix H to the 2018 IRP. The Commission opened this docket (UM 2030) to conduct an investigation into the use of the proposed methodology, and adopted Staff's proposed framework consisting of two phases.

This workshop will be the first step in Phase 1 of the investigation. NW Natural will present its updated Appendix H RNG evaluation methodology at the workshop, and stakeholders may ask questions to gain an understanding of the avoided cost methodology.
