Background

House Bill 2165 creates a dedicated funding resource for investments by requiring PGE and PacifiCorp to collect a monthly meter charge equal to 0.25% of the total revenues. These funds are the minimum amount that must be invested, with at least 50% each year needing to be expended annually on underserved communities. The budget must be approved by the PUC and relate to elements in the utility's accepted TE Plan. Accounting for HB 2165 revenue and expenditures needs to be separate from other funds and must be reported to the PUC. The PUC needs to determine the manner and timing of this reporting.

Section 4 of HB 2165 adds several important definitions and changing the requirements to TE Plan approval. Definition updates include the addition of "infrastructure measures" as a TE program. It updates PUC criteria around the types of TE investments and the minimum requirements for an approvable utility TE plan.

In Order No. 21-026 (April 2021), the Commission directed Staff to develop a holistic TE "investment framework" to meet the goals set forth in Executive Order 20-04.
