NOTICE OF PROPOSED UPDATED SCHEDULE FOR 2022 ALL-SOURCE REQUEST FOR PROPOSAL PROCEEDING

On September 2, 2021, in accordance with the competitive bidding rules adopted by the Public Utility Commission of Oregon (Commission), PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) filed an application requesting an order: (1) opening a docket for approval of PacifiCorp's 2022 All-Source (2022 AS) Request for Proposals (RFP), which is a solicitation process for the acquisition of approximately 1,345 megawatts (MW) of new generating resources and 600 MW of energy storage resources targeting a commercial operation date on or before December 31, 2026; (2) appointing an independent evaluator (IE) to oversee the 2022 AS RFP process; and (3) approving the proposed RFP scoring and modeling.

In its application, because of the time-limited nature of this resource opportunity and the tight initial shortlist deadline prior to the close of the Cluster Study 2 Request Window,

PacifiCorp proposed a compressed procedural schedule for this docket. However, after filing the Application, the Company engaged in discussions with Staff in part to discuss the schedule. As a result, the Company is submitting the following updated schedule for the Commission's consideration:
