Line/Grandfather of Service/New Bundle Package.

I have reviewed this filing and recommend that an acknowledgement letter be sent.

Applicable Rule or Law

Telecommunications utilities are required by ORS 759.175 to submit tariff filings to the Commission whenever they intend to change their rates, terms, or conditions of service. Ziply Fiber Northwest, LLC Ziply Fiber (Ziply) operates under a price plan pursuant to ORS 759.255, under which the Commission regulates prices without regard to the return on investment of the utilities. The Ziply Price Plan was approved in Docket No. UM 1895 with Order No. 18-303, and became effective on August 17, 2018.

Among its numerous provisions, the Ziply Price Plan contains price rules (most often in the form of price caps) and availability requirements for various services, including Primary Line Basic Service (PLBS). Section 1(g) of the Price Plan defines PLBS as the first line only of basic local exchange service for an individual residential or business customer that is not sold as part of a package. Under Section 4(e)(i) of the Price Plan, the Companies may increase monthly flat rates for residential PLBS services by a maximum of \$3.00 per Price Plan year, with a maximum increase of \$10.00 over the four-year term of the Price Plan. Section 4(e)(i) of the Price Plan also limits the line component of the residential measured service rate to 70 percent of the flat residential PLBS rate.

Section (9) of the Price Plan requires tariff changes to be filed with the Commission at least 30 days prior to the effective date of the change and requires the Companies to provide customers subscribing to affected service 30 days' notice of any increases.

<u>Analysis</u>

On April 12, 2022, Ziply submitted ADV 1388/Advice No. 2022-1. The purpose of the filing is to increase the Residence Access Line monthly rate. Certain package prices have also been updated to reflect the Residence Access Line increase. Customers

began receiving notifications on April 5, 2022, and will continue to receive notifications via bill message until May 5, 2022, with an effective date of May 15, 2022.

During analysis, Staff found numerous clerical errors and one possible Price Plan violation. The possible violation found is the customer notification. Per the advice filing, the last customer notification was sent on May 5, 2022, with the effective date of May 15, 2022, leaving only 10 days from notification to effective date. Per section (9) of the price plan, Ziply is required to give at least a 30 day notification to all customers. Staff sent numerous emails in regard to the clerical errors, as well as the possible Price Plan violation starting on May 3, 2022, and the last email was sent on June 29, 2022. All clerical issues were resolved during this time, but the question of whether or not all customers received at least 30 days' notice was not answered. The last email Staff received from Ziply was on July 6, 2022, which stated they are still researching the question and will get back to Staff. Staff sent a follow up email again on July 12, 2022, and received no response.

The following changes have been made to the OPUC No. 18 Tariff as well as the Oregon Price List No. 2:

Conclusion

Staff discussed with PUC counsel in regard to approving the advice filing since the effective date has passed and all customers have been notified at this point. PUC counsel advised Staff that due to statute of limitations, it is OK to process. Staff recommends PUC counsel discuss with Ziply Counsel the timeliness and responsiveness of Ziply to Price Plan violations. Other than the customer notification issue, Staff finds that the filing complies with Oregon statutes, applicable Price Plan requirements, and the requirements of ORS 759.175, and therefore should be allowed to go into effect.
