**SUBJECT:** ZIPLY FIBER NORTHWEST, LLC dba ZIPLY FIBER:

(Docket No. PL 225/Advice No. 2023-06) Increases monthly rates for certain residential telephone bundles in Statewide Pricelist No. 2.

I have reviewed this filing and recommend that an acknowledgement letter be sent. With this filing, Ziply Fiber Northwest, LLC (Ziply NW or Company) increases the monthly rate for certain residential telephone bundles. The bundle prices will be increased to reflect the increase in the access line rate. This filing also increases rates on certain Grandfathered bundled services.

## Applicable Rule or Law

Telecommunications utilities are required under ORS 759.175 to submit tariff filings to the Commission whenever they intend to change their rates, terms, or conditions of service. Ziply NW is also regulated under a Price Plan pursuant to ORS 759.255.1

Section 9.b of the Price Plan requires Ziply NW to provide 30-day notice of price increases to customers subscribing to the service. Retail customer notices may be made by bill message, including notice to customers receiving electronic bills. Section 9.a also requires price list changes to be filed with the Commission at least one day prior to the effective date of the change.

## Analysis

With this filing, Ziply NW implements the following rate increases.

The filing was submitted on December 13, 2023 with an effective date of January 2, 2024. Per the Advice filing, the customers began receiving notification of the price increase on November 20, 2023 via bill message and will continue to receive notifications thru January 2024 bringing Ziply NW in compliance with the 30 day notice requirement for price increases as stated in section 9.b of the price plan. Staff has reviewed the price of all individual components for the Packaged/Bundled Services and has found that the Packaged/Bundled price does not exceed the combined total of each component per section 4.q of the Price Plan.

## Conclusion

This filing complies with applicable laws and Commission orders. The filing should be allowed to become effective, and an acknowledgement letter should be sent. No further action is necessary.
