Re: PCN 5—PacifiCorp's Additional Materials to Supplement Stop B2H Coalition's Exhibits

On May 2, 2023, PacifiCorp d/b/a Pacific Power (PacifiCorp) filed its Objection to Certain Motions to Admit. In section III of the filing, PacifiCorp addressed the exhibits offered by Stop B2H Coalition and noted the following corrections were needed:

First, with respect to Exhibit Kreider/301, PacifiCorp filed an errata to PAC/202 to Mr. Link's rebuttal testimony in this proceeding. This same errata was filed to Mr. Link's direct testimony submitted in the Company's Idaho and Wyoming CPCN proceedings. The original filed testimony of Mr. Link for the Company's Wyoming and Idaho CPCN applications were provided in the first supplemental response to DR OPUC 13, which is included in Exhibit Kreider/300. Second, there was a first supplemental response to DR OPUC 3, which also should be added to Stop B2H/300 for completeness purposes.
