1           My name is Gordon Feighner, and my qualifications are listed in CUB Exhibit  
2   101.

3           Idaho Power Company (hereafter, "Idaho Power" or "the Company") filed its  
4   2011 Annual Power Cost Update (APCU) on October 15, 2010. The testimony supplied  
5   by the Company in this filing (Idaho Power/100/Wright) addresses the Company's  
6   October Update for the APCU. CUB analyzed this testimony and raised several issues in  
7   discovery, which were adequately addressed by the Company. CUB does not seek to  
8   raise any substantive issues here, but does reserve the right to raise any issues related to  
9   continuing discovery efforts. CUB also anticipates that Idaho Power's March Update  
10   filing, which is due on March 23, 2011, will bring forth significant power cost  
11   adjustments for the Company's hydro system, as 2011 is shaping up to be a very good  
12   water year. Further discovery will likely lead CUB to submit more detailed testimony in  
13   rebuttal to the March Update.
