I, Deborah J. Stare, being first duly sworn, depose and say:


1. I make this Affidavit to verify the Prepared Direct Testimony of Deborah J. Stare, filed December 15, 2005, on behalf of Wah Chang, as Exhibit WC/900, in this proceeding.
2. I am a paralegal employed by the law firm of Lane Powell PC, attorneys for Petitioner herein.
3. I have reviewed my prepared direct testimony filed December 15, 2005. The testimony, as filed, is a true and correct statement of my testimony in this proceeding, with the exception of one correction.
4. On page 2 of my prepared testimony filed December 15, 2005, the following question and answer appears:

**Q: There are notations, both handwritten and typewritten, on some pages of the transcript. Please explain what the notations represent.**

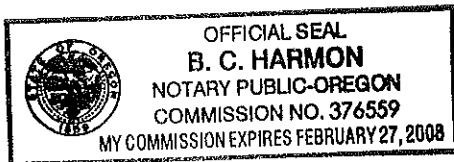
1 A: First, I went through the audio files, from which the transcription was  
2 taken, and cross-referenced each audio file to the transcript. The  
3 transcriptionist had labeled the audio transcriptions as "Conversation 1",  
4 "Conversation 2", etc. I applied either a typewritten label, identifying the  
5 corresponding audio file by date, time and file size, or, if a conversation was  
6 included in an audio file with another conversation, I noted "Included with  
7 Conversation \_\_\_". An example of a file name is 070100\_1253.wav (See  
8 Exhibit 901, Conversation 1, page 2). As I understand it, "070100"  
9 represents the date of the conversation, and "1253" represents its **duration**.  
10 [Emphasis added.]


11 The term "duration" is incorrect. As I understand it, the "1253" in the example provided  
12 represents the time of the call, not the duration.
