## FIRST AGREEMENT AMENDING STANDARD POWER PURCHASE AGREEMENT

THIS FIRST AGREEMENT AMENDING STANDARD POWER PURCHASE AGREEMENT ("First Amendment") is between Pacific Northwest Solar, LLC ("Seller") and Portland General Electric Company ("PGE") (each a "Party" or collectively, "Parties").

Seller and PGE are Parties to that certain Standard Renewable In-System Variable Power Purchase Agreement dated May 20th, 2016 ("Agreement"), regarding sale of the Net Output of the 4,000 kilowatt Amity Solar facility located in Yamhill County, Oregon ("Facility"). Seller and PGE desire to amend the Agreement as provided below.

NOW THEREFORE, the Parties mutually agree as follows:

1. <u>Term</u>. This First Amendment will become effective on the date executed by both Parties and will remain in effect until: (a) the Agreement is terminated; or (b) this First Amendment is terminated in writing by mutual agreement of the Parties.

2. <u>Amendment of the Agreement</u>. The Parties hereby agree to the following amendments to the Agreement:

2.1 In Section 2.2.1 of the Agreement, the date 11/01/2017 is deleted and replaced with the date 11/30/2019.

2.2 In Section 2.2.2 of the Agreement the date 12/31/2017 is deleted and replaced with the date 12/31/2019.

3. <u>No Other Changes: Entire Agreement</u> Except as expressly provided in Section 2 of this First Amendment, all of the terms and conditions in the Agreement, and all of the exhibits to the Agreement will remain unaffected and in full force. This First Amendment supersedes all prior agreements, proposals, representations, negotiations, discussions or letters, whether oral or in writing, regarding amendment or modification of the Agreement.
