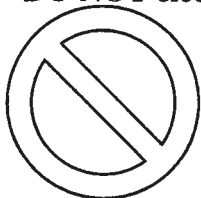

Threemile Canyon Wind I, LLC does not own overhead electric supply facilities and hence has no overhead electric supply inspections to report.


Echo Projects

Big Top, LLC; Butter Creek Power, LLC; Four Corners Windfarm, LLC; Four Mile Canyon Windfarm, LLC; Oregon Trail Windfarm, LLC; Pacific Canyon Windfarm, LLC; Sand Ranch Windfarm, LLC; Wagon Trail, LLC; and Ward Butte Windfarm, LLC; collectively the "Echo Projects"; are co-owners of certain electrical and communications facilities for the transmission of electricity from the Echo Projects' Collector Substation to PacifiCorp's Hinkle Substation. The Echo Projects do not own any other overhead electric supply facilities.

The Echo Projects report that more than 50 percent of the co-owned electrical and communications facilities for the transmission of electricity from the Echo Projects' Collector Substation to PacifiCorp's Hinkle Substation were inspected pursuant to OAR 860-024-0011(1)(b) within the first five years of the 10-year interval period. In fact, 100 percent of such facilities were inspected within the first five years of the 10-year interval period. Consequently, the next reporting on behalf of the Echo Projects will be made in 2019.
