Enclosed for filing by Portland General Electric is the Company's Bi-Annual Report for the period January 31, 2012 through June 30, 2012, for the Oregon Solar Incentive Program. This filing is submitted in compliance with OAR 860-084-0430. In the interests of standardization and ease of use and as our data is very similar, we have adopted the format used by PacifiCorp to file this information.

In addition, at the August 14, 2012 OPUC Public Meeting, the Commission adopted Staff's recommendation that the utilities provide the following data by rate class no later October 1, 2012. This information fulfills parts b(i) and b(ii) of the requirement in Staff's report. The information required in Part b(iii) was provided in our comments filed on July 27, 2012.

Summary of Pilot Program – January 31, 2012 through June 30, 2012

Portland General Electric has offered five reservation periods for capacity under the Solar Photovoltaic Incentive Rate Pilot Program. The available capacity in the first three reservation periods was fully subscribed within minutes. The October 3, 2011 reservation period saw significant changes which resulted in the reservation period closing with capacity remaining available for small-scale projects. The April 2, 2012 reservation period experienced a return to a fully subscribed program.

July 1, 2010, Reservation Period Results

The July 1, 2010 reservation period has concluded with 84 projects fully interconnected with contracts in place, and operating. Twenty (20) projects have withdrawn their reservation or failed to meet the two-month deadline as required by OAR 860-084-0230(3). Participants failing to meet this requirement were removed from the program. The information is summarized in the table below.
