This update includes electric and gas forward curves based on a five-day average of the November 1, 2011, through November 7, 2011, forward curves. PGE's final Net Variable Power Cost (NVPC) forecast for 2012 totals approximately \$702.9 million, a decrease of roughly \$2.75 million from the November 4, 2011, update filing. This decrease is largely driven by PGE's inclusion of the adjustment to power costs from OPUC Order No. 11-432.
