THIS AMENDMENT ("Amendment") THREE by and between **Qwest Corporation d/b/a CenturyLink QC** ("CenturyLink") and ("Customer") hereby amends the CenturyLink ISDN PRS, DSS Advanced, or UAS ICB Agreement or Supplement retained under Content ID 855435, 811329 and 1023145 between Customer and CenturyLink, as may have been previously amended (the "Agreement"). Except as set forth in this Amendment, capitalized terms will have the definitions assigned to them in the Agreement.

- 1. **Modifications.** CenturyLink and Customer wish to amend the Agreement as shown below. Customer will pay for all charges associated with such modification. CenturyLink's records will document the actual date of installation. Service may be added up to 12 months prior to the expiration of the Agreement.
- 2. Additions to Services. Amendment Three is adding the locations attached hereto, and these locations are replacing in their entirety the locations that were listed under Amendment Two (Content ID 1023145).
- 3. **Miscellaneous.** This Amendment will be effective as of the date it is executed by CenturyLink after the Customer's execution (the "Amendment Effective Date") and be deemed incorporated by reference into the Agreement. All other terms and conditions in the Agreement will remain in full force and effect and be binding upon the parties. This Amendment and the Agreement set forth the entire understanding between the parties as to the subject matter herein, and in the event there are any inconsistencies between the two documents, the terms of this Amendment will control.

The undersigned parties have read and agree to the terms and conditions set forth in this Amendment. Electronic signatures on this Amendment will be accepted only in the form and manner prescribed by CenturyLink.

AMENDMENT TO THE CENTURYLINK ISDN PRS, DSS, OR UAS INDIVIDUAL CASE BASIS ("ICB") RATE PLAN AGREEMENT

FOR THE STATE OF OREGON PRICING ATTACHMENT

Customer

This ISDN PRS is provided by Qwest Corporation d*lola* CenturyLink QC ("CenturyLink QC") and is subject to the CenturyLink® Total Advantage® Express Agreement between Customer and CenturyLink.

Filing Concurrence

CenturyLink may be required to submit this Agreement and any subsequent addenda for ISDN PRS to certain regulatory agencies for approval because the rates and some terms in this Agreement are being offered on an individual case basis ("ICB"). The ISDN PRS rates on this Exhibit 1 and the terms in ISDN PRS Section of this Agreement require filing with or approval by regulatory agencies ("ICB Terms"). Although the general terms and conditions of this Agreement are effective on the Effective Date, the ICB Terms will not become effective for a given jurisdiction until the filing and approval requirements for that jurisdiction are fulfilled. Service will be offered in accordance with the applicable Tariff until the ICB Terms become effective. If Customer receives reduced pricing under this Agreement and a regulatory agency later invalidates the ICB Terms after they had become effective, Customer will pay to CenturyLink any difference in the amounts listed in the applicable Tariff for ISDN PRS and the amounts Customer was charged for ISDN PRS. When approved by the regulatory agencies, Customer may add additional quantities of ISDN PRS pursuant to the Service Changes Section under the same terms and conditions with no further filing required. If a regulatory agency does not approve this Agreement, the parties will enter into good faith negotiations to mutually resolve the failure to receive the necessary approval. This Agreement will remain in full force and effect for ISDN PRS in all other jurisdictions.
