The Non-Telecom Services Surcharge is a fee that applies only to Home Phone II when the customers subscribes to or the package includes Voice Messaging Service, a service which is deregulated. The Home Phone II package is non-essential because the components of the package are already offered out of the Oregon Tariff and Price List. Due to the timing of the Price Plan, Home Phone II was not moved to the Price List along with other similar packages and bundles. The requested effective date of this filing is July 17, 2015, which is the date affected customers were notified the increase would begin.
