This Tariff includes revisions to the conditions and rates for the following seven (7) companies:

Canby Telephone Association Clear Creek Mutual Telephone Company Eagle Telephone System, Inc. Molalla Communications Company Mt. Angel Telephone Company Nehalem Telecommunications, Inc. Scio Mutual Telephone Association

Section 12 of this Tariff PUC Or. No. 3, Access Services, include each of those Company's rates and charges.

This filing is made in compliance with the Federal Communication Commission's Title 47: Telecommunication; Part 51-Interconnection; Subpart J-Transitional Access Service Pricing; §51.909 Transition of rate-of-return carrier access charges; Step 7.



Federal Communication Commission ("FCC") rules require National Exchange Carrier Association ("NECA") members companies to adjust their capped interstate switched access rates for July 3, 2018. NECA has informed its member companies that pool election changes for the upcoming tariff year will increase rates by 0.222 percent. Around June 18, 2017 NECA will file with the FCC modified rates for interstate, intrastate terminating access rates (which will be in parity with interstate rates) and the required end office element rate step-down in accordance with federal rules.

The state terminating switched access rate changes match the CAF ICC Intrastate Tariff Rate Plan (TRP), which are proposed for July 3, 2018.

Other than noted above, this filing will not increase any rate or charge, cause the withdrawal of service, or conflict with other schedules. This filing is revenue neutral for these Companies.

It is requested that this filing become effective July 3, 2018.
