In compliance with Order No. 21-414 and amended by Order No. 21-439, and at the request of Public Utility Commission of Oregon (Commission) Staff, PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) submits for filing a proposed tariff sheet associated with Tariff P.U.C. OR No. 36, which sets forth all rates, tolls, charges, rules, and regulations applicable to electric service in Oregon. The purpose of this filing is to confirm that the rates for customer deposit interest and late payments approved in Order No. 21-414 and amended by Order No. 21-439 are reflected in PacifiCorp's billing system and tariffs effective January 1, 2022. A less than statutory notice application is included with this filing.

In Order No. 21-414 and amended by Order No. 21-439, the Commission approved an annual interest rate of 0.1 percent on customer deposits and a late payment rate of 2.0 percent for calendar year 2022. PacifiCorp is in compliance with Order No. 21-414 as amended by Order No. 21-439. As there is no change to the annual interest rate of 0.1 percent for customer deposits, no billing system changes are necessary to reflect the correct interest rate. The late payment fee percentage is reflected in the Company's tariff Schedule 300 Charges as Defined by the Rules and Regulations, Sheet No. 300-2 to be effective January 1, 2022. The change to Schedule 300 is attached to this filing.
