Northwest Natural Gas Company, dba NW Natural ("NW Natural" or "Company"), files herewith the following revisions to its Tariff P.U.C. Or. 25¹, stated to become effective on and after January 1, 2022:

This filing is made in accordance with OAR 860-022-0025 and OAR 860-022-0045.

Purpose

The purpose of this filing is to revise Schedule 301 Public Purposes Funding Surcharge to update the portion allocated to the Energy Trust of Oregon ("ETO").

Proposed Changes

The purpose of this filing is to revise the portion of public purpose funds allocated to the ETO for the administration of residential and commercial energy efficiency programs from 3.70% to 4.18%. This change is intended to provide the ETO with approximately \$28.2 million dollars of total program funding in 2022, which is sufficient to acquire nearly 4.2 million of therm savings.

Attached are worksheets demonstrating the calculation of the rate and the impact this will have on customer bills. Bill impacts are summarized in the table below.
