Pursuant to ORS 759.250, Qwest Corporation, d/b/a CenturyLink QC is filing notification of a Special Contract for Digital Switched Service (DSS) and ISDN Primary Rate Service (PRS). This agreement was signed November 19, 2019.

C02-2020 is a continuation of the provision of services provided under an active contract. The renewal (or extension) contract is being filed as a new contract pursuant to ORS 759.250 because it would exceed the statutory 5-year limitation. A financial/cost analysis is provided as a part of the filing.

Due to the competitive nature of this Special Contract, the information provided in Attachment C contains commercially valuable information and/or trade secrets and is submitted to Staff in confidence pursuant to ORS 192.501 and ORS 192.502. Competitive alternatives such as resale of CenturyLink QC service are available to customers.
